 - Toured the Arcadia Daycare on Wednesday with Sue McKay and Janelle Gibson, & Thanh Bui-Duquette from HeadStart; Next step – meeting to discuss next steps; Tour of school district that has a public school/ HeadStart program
3. Staff Development
 - Oct 8th – Staff was trained in Frontline (the software for EE (Educator Effectiveness)); Staff reviewed fall MAP data, spring Forward data, ACT Aspire data, and ACT; Time to meet as PLC groups to develop their SLO, PPG, Self-Assessment, Rapid Cycle Feedback Planning; Special Ed worked on Compliance Review; Guidance Counselors worked on ACP framework
4. Budget Update
 - Mil Rate went from \$9.33 last year to \$8.73 this year (\$.60 decrease)
 - Defeasance: Irrevocable setting aside cash, assets, or levied funds for prepayment of debt. Funds go into an escrow/trust account. \$500,000 will be put into defeasance to reduce the referendum debt.
 - From Committee of the Whole:
 - o Increase in Fund 27 – support services- Business Administration was caused by increase in special ed transportation (operating the transit van)

- Increase in Fund 27 – instruction – Spec Ed Curriculum was caused by moving staffing positions out of CESA contracted services into district staff positions

- A. Solar Power Update
 - Called our contact 3 times; 2x a voice message was left to contact the school; 1x the voice mailbox was full
 - During the initial conversation the cost would be covered about the same time the panels would need to be replaced. Not a cost savings for the district. We are “land-locked” not a lot of space around the building to install the panels. Don’t want to put them on the roof due to roof maintenance.
 - Recommend – Keep eye open for other opportunities

COVID TESTING – Parental permission

- Consent form for 21-22 school year
- Parents will be contacted, and verbal permission received prior to each testing event
- Parents register at CovidConnect to receive test results

Testing Protocols (10/20/21)

- * Testing Protocols may be revised as necessary based on emerging information, Accelerated Clinical Laboratories, CDC, DHS, or County Health Dept. guidance.

Students who are displaying symptoms

Students will be given a Rapid Antigen test and a sample may be taken for PCR testing.

- A. Negative Result (Rapid Test) - Students will be allowed to return to school when they are fever free for 24 hours without the use of medication and symptoms have decreased.
- B. Positive Result (Rapid Test) – Student will be sent home to quarantine for 10 days since onset of symptoms.

Students who are not displaying any symptoms

If a student is determined to be a close contact to someone outside of their immediate household, parents will be given the option to agree to the testing protocol outlined below to allow students to remain in school. If parents choose not to allow/follow the testing protocol, the student will be sent home to quarantine for the full 14 days since exposure.

1. Student must stay home on days 1 & 2 from exposure.
2. On day 3, prior to going to class, a Rapid Test will be administered and a sample may be taken for PCR testing.

A. Negative Result (Rapid Test) - Students will be allowed to remain in school.

The student will be retested (Rapid Test) every 48 hours (on school days) through day 10.

On days 3 - 14 :

- The student will be required to wear a mask: *with or without a full school face-covering policy.*
- *The student will be unable to utilize school transportation,*
- *The student will be unable to participate in extracurricular and co-curricular activities.*
- The student will have alternatives to certain high-risk activities such as physical education, band, choir, recess and lunch locations.
- The student will be retested (Rapid Test) every 48 hours through day 10.
- The student can return to full activities on Day 15 provided they remain asymptomatic.

B. Positive Result (Rapid Test) - Student will be sent home to quarantine for 10 days from the positive test date.

** Reminder : Students who are vaccinated are not subject to close-contact quarantine and can fully participate in all school activities. However, they should monitor for symptoms for 14 days and be tested as soon as possible if symptoms develop.
